- 1) Only specialized and experienced companies that are licensed to carry out such Services will be eligible to purchase the Tender Documents. Therefore, candidates are advised to bring their companies' introductory documents at the time of purchase of the Tender Documents.
- 2) Organized tour of the Services sites for prospective bidders who successfully met the criteria for purchasing the Tender Documents will be arranged on 10:00 am of Wednesday, June 15th, 2011. Details and conditions of the site visit are provided in the Instruction to Tenderers (Part I of Volume 1 of the Tender Documents).
- 3) Deadline for enquiries is at 3:00 pm of Wednesday, June 22nd, 2011.
- 4) Deadline for Tender submission is at 3:00 pm of Thursday, July 14th, 2011, to the address and details set forth in the Tender Documents.

- 5) Tenders shall be furnished with a Tender Security in the amount of JD 10,000 (Ten Thousand Jordanian Dinars) in the envelope specified in the Tender Documents. Tender Security shall be in the form of a certified cheque or a guarantee from a bank located in Jordan or a foreign bank that is licensed or allowed to do business in Jordan. Tender and Tender security shall be valid for a period of 120 days from the Tender submission deadline. Tenders not accompanied with the required Security shall be rejected.
- 6) Kemapco holds no obligation to award the Tender to the lowest price and reserves its right to accept or reject any Tender, and to annul the tendering process and reject all Tenders, at any time prior to award of Agreement, without thereby incurring any liability to the affected tenderer or tenderers or any obligation to express the grounds for Kemapco's action.
